

### **Provider Access Policy**

#### Introduction

This policy statement sets out the school's arrangements for managing the access of providers to pupils at the school for the purposes of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997 and the updated Provider Access Legislation (PAL) enacted in January 2023.

#### **Student entitlement**

Students in years 7 - 11 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point.
- To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships through options evenings, assemblies and group discussions and taster events.
- To understand how to make applications for the full range of academic and technical courses.

The updated PAL specifies schools must provide at least four encounters with approved providers of apprenticeships and technical education for all their students:

- Two encounters for pupils during the 'first key phase' (year 8 or 9) that are mandatory for all pupils to attend
- Two encounters for pupils during the 'second key phase' (year 10 or 11) that are mandatory for all pupils to attend

This new legislation will become a key mechanism to further help learners understand and takeup, not just apprenticeships, but wider technical education options such as T-Levels and Higher Technical Qualifications.

#### **Opportunities for access**

All students, parents and families have access to a Level 6 qualified Careers Advisor. The adviser attends Parents Evenings, GCSE Choices Evening and is available for individuals and families to book appointments. Please contact Lee Gordon using the details above.

Students are able to contact Mr Gordon via lunch time drop ins, when passing between lessons, by email and through form tutors.

Providers are welcome to leave a copy of their prospectus or other relevant course literature in the Careers Office, which is managed by the named contact. The Careers Office is available to all students at lunch times as well as during careers appointments etc.

Careers information, prospectuses etc can be handed out during a.m. registrations through LG visiting form groups OR at the end of an assembly/provider talk.

All students participate in a Careers Challenge Day which covers the topics listed below. Other events and visits take place during the academic year.

	A series of classroom-based programmes developed to help students learn more about themselves and both the opportunities and the responsibilities of adult life in a fun and constructive way. Students learn:

Content of Careers Challenge Days		
Year 8	GCSE Choices Students take part in the following activities to help them make informed decisions about their GCSEs starting in Year 9: • Get to know yourself • Decision Making • Unifrog – an online platform helping to explore career ideas based on strengths and likes • Progression routes at 16 – what can you do when you leave school? • LMI (Local/Labour Market Information)/Real Life Choices The Challenge Day is followed by a Parents Event offering opportunities to talk to subject staff, local colleges and universities (tbc).	
Year 9	In 2020 and 2022, through Higher Horizons+, the Year 9s took part in a 'Design a University Open Day' activity lead by the National Enterprise Challenge. Each group selected a Project Manager, agreed on a target student and then planned a day based on that student's aspirations to try and encourage them. Presentations by student teams needed to include information on finance, degree apprenticeships, non course options etc. In 2023, it became the 'Moorside High Ideal University' event based on and using similar aims, activities and outcomes.
